**DEFENDANTS' RESPONSE TO ORDER
TO SHOW CAUSE RE: BASELINE
STAFF TESTING FOR COVID-19**

19 **INTRODUCTION**

20 Defendants' respectfully submit this response and objection to the Court's Order to Show
21 Cause on the grounds that (1) an order from the Court requiring baseline testing is unnecessary
22 because CDCR already intended to conduct baseline testing at some institutions and now, after
23 considering Plaintiffs' and the Court's concerns, intends to conduct baseline testing at each of the
24 institutions and (2) it is not feasible to conduct baseline testing at all of the institutions between
25 now and July 6, 2020, but CDCR should be able to complete the baseline testing by July 16, 2020.

26 **I. CDCR HAS ALREADY CONDUCTED SIGNIFICANT STAFF TESTING IN**
27 **THE INSTITUTIONS.**

28 The Court's Order to Show Cause indicated that, aside from the Court ordered testing at

1 San Quentin and California State Prison, Corcoran, the Court may not have been aware of staff
 2 testing at other institutions. CDCR's testing efforts to date have been extensive and are
 3 summarized below:

- 4 • 1,603 staff tested at California Institution for Men in May and June;
- 5 • 1,725 staff tested at San Quentin in mid-June and retesting of all San Quentin staff
 6 is scheduled to begin today;
- 7 • 1,949 staff tested at Corcoran in mid-June;
- 8 • 286 staff tested at California Institution for Women on June 8, 2020;
- 9 • 380 staff tested at California Men's Colony on June 11, 2020;
- 10 • 1,164 staff tested at Avenal State Prison in late May and serial testing at Avenal
 11 commenced on June 23, 2020;
- 12 • 1,939 staff tested at California Medical Facility from June 24-30, 2020;
- 13 • 2,959 staff tested at California Health Care Facility from June 24-30, 2020;
- 14 • 1,018 staff tested at Central California Women's Facility from June 26-30, 2020;
 15 and
- 16 • 1,142 staff tested at California State Prison, Solano from June 26-30, 2020. (Decl.
 17 J. Osborn ¶ 3.)

18 Furthermore, voluntary staff testing commenced at California Correctional Center on June
 19 18, 2020. Mandatory testing of the remaining staff at that institution is already scheduled to
 20 commence on July 1, 2020, and serial testing is scheduled to begin on July 15, 2020. (*Id.* at ¶ 4.)
 21 Finally, testing of all staff at High Desert State Prison was already scheduled to commence on July
 22 1, 2020. (*Id.* at ¶ 5.) As this data shows, CDCR takes staff testing extremely seriously, and has
 23 made significant efforts to test staff even before a statewide staff testing plan has been
 24 implemented.

25 **II. THE COURT'S PROPOSED TESTING ORDERS ARE UNNECESSARY AND**
 26 **WOULD IMPOSE AN UNREASONABLE DEADLINE.**

27 The Court is correct that the staffing plan Defendants filed with the Court did not require
 28 baseline testing at every institution, but as Defendants have repeatedly emphasized, CDCR's

1 planned responses to the pandemic are subject to frequent changes as the situation evolves and
2 new information and recommendations are evaluated. On the issue of staff testing, CDCR has
3 decided to change course and now plans to conduct baseline staff testing at each institution and
4 will prioritize the testing at California Correctional Institution and other prisons that have
5 significant outbreaks. (*Id.* at ¶ 6.) In addition, retesting of all staff at San Quentin was already
6 scheduled to commence on June 30, 2020, before the Court issued the Order to Show Cause. (*Id.*
7 at ¶ 3.) And testing of the remaining staff at California Correctional Center was already scheduled
8 to commence on July 1, 2020, again, before the Court issued the Order to Show Cause. (*Id.* at ¶
9 4.) Thus, the Court's proposed order for baseline testing at all prisons is not necessary.

10 Additionally, the Court's proposed order is objectionable because the deadline it would
11 impose for completion of testing is simply not feasible. (*Id.*) This is due to the time required to
12 complete contracts with testing providers, the time required to schedule and arrange for testing,
13 additional administrative complications related to completing contracts during the transition from
14 one fiscal year to the next, and anticipated difficulties in making progress on this project through
15 the holiday weekend when many staff will be on vacation. (*Id.*) Based on consultations with the
16 primary contractor that will likely conduct the bulk of the baseline staff testing, CDCR estimates
17 that it can complete the baseline testing by July 16, but will endeavor to complete it sooner. (*Id.*)
18 CDCR anticipates, however, that staff testing at institutions with significant outbreaks, including
19 California Correctional Institution, will be completed well before July 16 because testing at those
20 institutions will be completed first. (*Id.*)

21 Lastly, in light of the fact that some of the staff testing contemplated in the Court's Order
22 to Show Cause was already underway, and the fact that CDCR now intends to conduct baseline
23 staff testing at every institution and will complete that testing by July 16 at the latest, the orders
24 contemplated in the Order to Show Cause could not satisfy the Prison Litigation Reform Act's
25 (PLRA) needs-narrowness-intrusiveness requirements. 18 U.S.C. § 3626(a)(2). To the contrary,
26 those contemplated orders would not be the least intrusive means to correct a constitutional
27 violation, and they extend further than necessary to correct a harm in violation of the of the PLRA.

**DECLARATION OF JENNIFER OSBORN
IN SUPPORT OF DEFENDANTS'

20 I, Jennifer Osborn, declare:

21 1. I am employed by the California Department of Corrections and Rehabilitation
22 (CDCR) as the Director of the Division of Administrative Services. I have held this position since
23 since December 2018. I have personal knowledge of the matters set forth in this declaration and
24 could and would competently testify to them. I submit this declaration in support of Defendants'
25 response to the Court's order to show cause regarding staff testing.

26 2. The Division of Administrative Services has been responsible for obtaining COVID-19
27 testing services for staff at CDCR's prisons. Accordingly, the Division has kept track of the staff
28 testing it has arranged and also conducts contact tracing based on testing results.

3. The following summarizes the staff testing that CDCR has conducted since May:
- 1,603 staff tested at California Institution for Men in May and June;
 - 1,725 staff tested at San Quentin in mid-June and retesting of all San Quentin staff is scheduled to begin on June 30, 2020;
 - 1,949 staff tested at Corcoran in mid-June;
 - 286 staff tested at California Institution for Women on June 8, 2020;
 - 380 staff tested at California Men’s Colony on June 11, 2020;
 - 1,164 staff tested at Avenal State Prison in late May and serial testing at Avenal commenced on June 23, 2020;
 - 1,939 staff tested at California Medical Facility from June 24-30, 2020;
 - 2,959 staff tested at California Health Care Facility from June 24-30, 2020;
 - 1,018 staff tested at Central California Women’s Facility from June 26-30, 2020; and
 - 1,142 staff tested at California State Prison, Solano from June 26-30, 2020.

4. Voluntary staff testing commenced at California Correctional Center on June 18, 2020, mandatory testing of the remaining staff is scheduled to commence on July 1, 2020, and serial testing is scheduled begin on July 15, 2020. These plans were made before the Court issued the Order to Show Cause.

5. Testing of all staff at High Desert State Prison was already scheduled to commence on July 1, 2020, before the Court issued the Order to Show Cause.

1 6. CDCR has decided to conduct baseline staff testing at all institutions. My staff and I
2 have been working to put contracts in place that will provide all needed staff testing. Yesterday, I
3 consulted with the contractor that will likely perform most of the baseline testing to inquire
4 whether it would be possible to complete baseline staff testing at all prisons by July 6, 2020. The
5 contractor advised that it would not be possible to complete the testing by July 6, but predicted
6 that the baseline testing could be completed at all prisons by July 16. Based on my experience
7 working with contractors to complete staff testing, I agree with this assessment. This is due to the
8 time required to complete the contracts with testing providers, the time required to schedule and
9 arrange for testing, additional administrative complications related to completing contracts during
10 the transition from one fiscal year to the next, and anticipated difficulties in making progress on
11 this project through the holiday weekend when many staff at the institutions are on vacation.
