



1 a substantial risk of serious harm to which Defendants are deliberately indifferent. The inmates  
2 seek declaratory and injunctive relief from the alleged constitutional violations.

3 After reviewing the substantial record compiled by the parties, which includes four neutral  
4 expert reports, two outside expert reports commissioned at the County's request, declarations from  
5 two experts retained by Plaintiffs and various inmates, the court finds that Plaintiffs meet the  
6 standard for class certification set forth in Federal Rule of Civil Procedure 23 and as construed by  
7 the Ninth Circuit. It therefore certifies a class of inmates challenging jail safety and health care  
8 policies and practices, and a subclass of inmates challenging jail disability policies and practices.<sup>2</sup>

15 Plaintiffs first request that the court take judicial notice of 55 applications made by the  
16 Sheriff's Office to the Monterey Superior Court in an attempt to relieve overcrowding, and  
17 subsequent orders. *See* Docket No. 49-11, Ex. Z; Docket No. 54 at 1. The court takes judicial  
18 notice of these applications and orders because they were filed in state court. Second, Plaintiffs ask  
19 the court to take judicial notice of County charts documenting the jail's average daily population.  
20 *See* Docket No. 49-13, Ex. AA and BB; Docket No. 54 at 2. As the daily inmate population is  
21 verifiable and not in dispute, the court takes judicial notice. Third, Plaintiffs seek judicial notice of  
22 minutes of the Monterey County Board of Supervisors in which the Board approved legislation to  
"accept the Jail Facility Needs Assessment Report." *See* Docket No. 49-16, Ex. FF; Docket No. 54  
at 3. The court takes judicial notice of this legislative enactment. Fourth, Plaintiffs request judicial  
notice of the Monterey County Correction Facility Information Manual and certain sections of the  
Custody Operations Bureau's Policies and Procedures. *See* Docket Nos. 49-1, Ex. E; Docket No.  
49-2; Ex. F; Docket No. 54 at 3-4. The court takes judicial notice of these agency manuals, rules  
and policies not subject to a reasonable dispute. Fifth, Plaintiffs ask for judicial notice of the  
United States Census Bureau Report on Americans with Disabilities. *See* Docket No. 49-17; Ex.  
II; Docket No. 54 at 4. The accuracy of these facts are verifiable and certain, and so the court again  
takes judicial notice.

23 The County first seeks judicial notice of Monterey County Board Orders: approving  
24 Amendment #1 to Agreement A-1083, *see* Docket No. 140-1, Ex. A; Docket No. 133-1 at 2;  
25 designating the Monterey County Sheriff's Office as the authorized representative on Medi-Cal  
26 applications, *see id.*, Ex. B; Docket No. 133-1 at 2; authorizing \$4,032,778 in County funds to be  
27 used for the County of Monterey Jail Housing Addition, *see id.*, Ex. C; Docket No. 133-1 at 2;  
28 authorizing an additional \$4,867,222 in County funds to be used for the Jail Housing Addition  
Project, *see id.*, Ex. D; Docket No. 133-1 at 2; and authorizing Sheriff Scott Miller to submit an  
application for a local adult detention facility construction grant and expenditure of \$200,000. *See*  
*id.*, Ex. E; Docket No. 133-1 at 2. The court takes judicial notice that these board orders occurred.  
Second, the County seeks judicial notice of affidavits and minute orders of conflict as to Glenda  
Hunter, Angel Perez, Ha Ngoc Tran, Dennis Guyot, Albert Key and Brandon Mefford. *See id.*, Ex.

## I.

1  
2 The United States and California Constitutions require California's counties to provide for  
3 the safety and well-being of inmates housed in county jails.<sup>3</sup> To meet these obligations, as well as  
4 those imposed by federal and state statutes,<sup>4</sup> Monterey County has promulgated extensive policies  
5 governing health care and conditions of confinement. These policies apply to all of the inmates in  
6 its custody and all of its staff throughout its main jail in Salinas.

7  
8 Since 1984, Monterey County has contracted with CFMG, a private health care provider, to  
9 provide medical, dental and mental-health care services to inmates. Under the terms of its contract,  
10 CFMG agreed to follow all County policies and to work with the County to implement additional  
11 policies governing such matters as health care staffing, access to prescriptions, emergency care,  
12 and mental health services. Monterey County regularly monitors CFMG's compliance with these  
13 policies.

14  
15 Twenty-one current or former inmates brought this suit. Plaintiffs allege a variety of jail  
16 policies and practices "fail to keep [inmates] safe from violence, to deliver adequate medical and  
17 mental health care or to provide required assistance to [inmates] with disabilities."<sup>5</sup> Plaintiffs  
18 support these general allegations with detailed references to dozens of specific jail policies and  
19 practices, including inadequate staffing, training, space, inmate classification, intake health

1 screening, care scheduling, medication, infection control, emergency response and suicidal inmate  
2 segregation.

3 Plaintiffs also claim that inmates are routinely denied reasonable accommodation for their  
4 disabilities. They allege, for example, that inmates who cannot climb stairs spend months without  
5 going outside because the exercise yard can only be accessed up a flight of stairs. Inmates who use  
6 sign language to communicate are not provided interpreters for the intake process, doctor's  
7 appointments and disciplinary hearings. Defendants are further alleged not to maintain any central  
8 list, electronic or otherwise, of inmates with disabilities and the accommodations they require. The  
9 result, say Plaintiffs, is that "because Defendants completely lack policies and practices for  
10 evacuating and communicating with [inmates] with disabilities in case of emergencies, including  
11 natural disasters and security incidents, [inmates] with disabilities are at increased risk of injury in  
12 such circumstances."<sup>6</sup>

14 With respect to all these claims, Plaintiffs allege that Defendants are aware of these  
15 constitutionally defective conditions and tolerate the resulting risk to which inmates are exposed.  
16 For example, Plaintiffs allege that in 2007, the County commissioned a third-party evaluation of  
17 the jail, which resulted in a June 19, 2007 report called "County of Monterey, Office of the Sheriff,  
18 Needs Assessment." The 2007 report concluded that "[t]he current combination of insufficient  
19 beds, an inadequate detention facility and understaffing has resulted in an almost untenable  
20 situation. In 2011, the County asked the third-party consultant to update the 2007 report to reflect  
21 amendments to state law and changes within the Sheriff's Office and the jail population. This  
22 updated report, dated December 30, 2011, reached the exact same, word-for-word conclusion:

1 “The current combination of insufficient beds, an inadequate detention facility and understaffing  
2 has resulted in an almost untenable situation.”<sup>7</sup>

3 Plaintiffs seek a declaration that Defendants are violating federal and state law and an  
4 injunction compelling Defendants to provide inmates with adequate protection from violence from  
5 other inmates, to provide inmates with adequate medical and mental health care, and to provide  
6 reasonable accommodations to and cease discriminating against inmates with disabilities.<sup>8</sup>

## 7 II.

8  
9 Shortly after filing their second amended complaint,<sup>9</sup> Plaintiffs moved for class  
10 certification. In addition to the detailed allegations of their complaint, Plaintiffs cite thousands of  
11 pages of documents that they secured by investigation and from public records requests, expert  
12 reports by four neutral specialists in prison medical care and conditions of confinement retained by  
13 mutual agreement of the parties, two reports on conditions at the jail commissioned by the County  
14 in 2007 and 2011, two declarations from experts they retained and their own declarations. The  
15 investigation and records requests produced (1) more than one hundred interviews of former and  
16 current inmates in the jail; (2) tens of thousands of pages of medical and custody records for  
17 current and former inmates in the jail; (3) documents produced by the County in response to three  
18 requests for information pursuant to the California Public Records Act and (4) hundreds of  
19 Sheriff’s Office reports of incidents that occurred in the jail.  
20

21 In their responses, Defendants submit declarations from attorneys, jail staff and medical  
22 experts, news articles, depositions, declarations, grievance and medical records of Plaintiffs, board  
23 orders for improvements and a letter from Monterey County Public Defender James Egar praising

1 CFMG's work.<sup>10</sup> They claim conditions have improved, despite difficulties due to inmate  
 2 realignment resulting from the enactment of Assembly Bill 109.<sup>11</sup>

3 **A.**

4 The 135-page second amended complaint in this case sets out detailed factual allegations  
 5 concerning the existence of jail policies and practices impacting the safety, health and disability  
 6 accommodations of all inmates. According to Plaintiffs, these policies and practices expose all jail  
 7 inmates to a substantial risk of harm.

8 Regarding their safety claims, Plaintiffs allege the following policies and practices: (1)  
 9 insufficient custody staffing; (2) inadequate inmate classification system; (3) dangerous and  
 10 inadequate jail facilities that are difficult to safely monitor; (4) housing more inmates in the jail  
 11 than the jail's rated capacity and (5) inadequate training of custody staff.

12 Regarding their medical care claims, Plaintiffs allege the following policies and practices:  
 13 (1) failure to provide timely access to health care; (2) insufficient custody staffing to ensure  
 14 inmates receive necessary health care; (3) insufficient health care staff to ensure the timely and  
 15 appropriate treatment of inmates' serious medical needs; (4) failure to adequately supervise health  
 16 care staff; (5) failure to provide adequate, clean and confidential clinical spaces;(6) inadequate or  
 17 non-existent written policies for intake health screening, health care requests, emergency response,  
 18 continuity of medications, care for inmates with chronic illness, housing of inmates in segregation,  
 19 care for developmentally disabled inmates, care for patients on dialysis, care for elderly patients,  
 20 care for patients with dementia, care for patients requiring wheelchairs, care for inmates who have  
 21 physical disabilities, housing for pregnant women, persons with communicable diseases, the  
 22 mentally ill and the terminally ill; (7) failure to adequately identify inmates in need of health care,

1 including inmates with chronic illness, during the intake process and thereafter; (8) use of  
2 inadequately trained custody staff to conduct intake health screening; (9) failure to provide  
3 adequate treatment to inmates with chronic diseases; (10) failure to provide adequate treatment to  
4 inmates with infectious diseases; (11) failure to provide timely and appropriately treatment by  
5 outside medical providers and specialists when necessary; (12) failure to provide timely and  
6 adequate treatment for inmates experiencing withdrawal; (13) failure to provide necessary  
7 medication and medical devices; (14) failure to timely and adequately respond to requests for  
8 health care; (15) failure to provide a confidential means for inmates to request health care; (16)  
9 failure to timely and adequately respond to health care emergencies; (17) failure to provide  
10 appropriate and timely post-operative and post-hospital discharge care; (18) failure to maintain  
11 adequate health care records; (17) failure to operate an adequate quality improvement program;  
12 (18) failure to adequately train medical and custody staff regarding the provision of health care to  
13 inmates and (19) failure to provide timely and appropriate dental care.

14  
15  
16 Regarding their mental health claims, Plaintiffs allege the following policies and practices:

17 (1) failure to provide mentally ill inmates medically necessary mental health treatment such as  
18 psychotropic medication, therapy and inpatient treatment; (2) failure to provide inmates access to  
19 timely and appropriate inpatient mental health care; (3) inadequate suicide prevention policies and  
20 practices; (4) failure to provide suicidal and self-harming inmates adequate mental health care; (5)  
21 housing inmates with mental illness in administrative segregation because they have mental  
22 illnesses; (6) failure to provide a clean, safe and therapeutic location for the housing of inmates at  
23 risk for suicide; (7) inappropriate use of safety cells, restraints and restraint chairs; (8) failure to  
24 adequately monitor inmates at risk of suicide and (9) failure to eliminate suicide hazards in  
25 administrative segregation.  
26  
27

1           Regarding their disability accommodation claims, Plaintiffs allege the following policies  
2 and practices: (1) failure to identify and track inmates with disabilities; (2) failure to identify and  
3 track the accommodations that inmates with disabilities require; (3) failure to ensure that inmates  
4 with disabilities receive and retain needed assistive devices and auxiliary aids; (4) failure to ensure  
5 that inmates with disabilities that require accommodations in housing receive and retain  
6 appropriate housing assignments; (5) housing inmates with disabilities in administrative  
7 segregation, where inmates have less access to programs, services, activities and privileges; (6)  
8 failure to provide sufficient housing for inmates in wheelchairs; (7) failure to ensure that each  
9 program, service or activity offered to inmates in the jail, when viewed in its entirety, is readily  
10 accessible to and usable by individuals with disabilities; (8) failure to ensure that each part of the  
11 facilities at the jail altered after January 26, 1992, in a manner that affects or could affect the  
12 usability of all or part of the jail, complies with relevant accessibility standards, including the  
13 Uniform Federal Accessibility Standards, the Americans with Disabilities Act Accessibility  
14 Guidelines and the 2010 Americans with Disability Act Standard for Accessible Design; (9) failure  
15 to provide effective communication to inmates with disabilities that affect communication; (10)  
16 failure to adequately take disabilities into account in the disciplinary process; (11) failure to  
17 provide sign language interpreters to inmates who use sign language as their primary method of  
18 communication; (12) failure to ensure the safe evacuation of inmates with disabilities in an  
19 emergency and (13) failure to operate an effective and prompt grievance system for inmates to  
20 request accommodations for their disabilities.  
21  
22

23           For each of these alleged policies and practices, the second amended complaint sets out  
24 multiple paragraphs or pages of particularized factual allegations. For example, regarding  
25 Defendants' alleged safety policies and practices, Plaintiffs allege roughly 150 separate instances  
26 of violence were reported from (presumably January) 2011 to September 2012, occurring in nearly  
27  
28



1 every area of the jail, and most requiring medical attention at the jail or the local hospital.

2 Weapons such as shanks and Tomahawks are “readily available” in the jail.<sup>12</sup> Surveillance is  
3 inadequate, as many assailants remain unidentified, most cameras do not have recording  
4 capabilities, and the jail’s understaffing means officers are rarely positioned to visually identify the  
5 attackers. Reporting is inadequate for fear of retaliation given the lax conditions. Undertraining of  
6 staff means inadequate intervention and confiscation of weapons. Plaintiffs say that despite  
7 incident reports and the 2007 and 2011 Jail Needs Assessments, Defendants lack policies and  
8 practices for regularly reviewing incident reports to identify systemic problems.<sup>13</sup>

9  
10 As another example, regarding the alleged medical care policies and practices, Plaintiffs  
11 claim that “[t]hough Defendants have a policy that all [inmates] are supposed to be seen by medical  
12 staff on the next available sick call day after submitting a sick call slip, in practice, Defendants use  
13 Licensed Vocational Nurses (LVNs) to screen the sick call slips and determine whether the  
14 [inmate] should actually be seen by medical or mental health care staff. No standardized protocols  
15 exist to guide LVNs’ exercise of discretion in determining when [inmates] should receive a face-to-  
16 face appointment with a nurse or other medical or mental health care clinician.”<sup>14</sup> Plaintiffs further  
17 allege that “[c]onsequently, LVNs arbitrarily determine whether the content of a sick call slip,  
18 often written by [an inmate] who can barely read or write, warrants an appointment with a nurse or  
19 physician.” Plaintiffs also detail the harm that members of the proposed class suffer as a result of  
20 these policies.<sup>15</sup>

1 As still another example of Plaintiffs' medical care claims, Plaintiffs allege that  
2 "Defendants have failed to implement appropriate triage procedures to ensure that non-emergency  
3 medical needs are attended to before they develop into emergencies." According to the complaint,  
4 Methicillin-resistant *Staphylococcus aureus* (commonly known as "staph") infections are  
5 frequently reported at the jail. Many inmates report filing multiple sick call slips for emerging and  
6 beginning staph-related wounds, but are not seen until their wounds develop into serious and  
7 emergency conditions requiring intense treatment.<sup>16</sup> The complaint explains that "one [inmate]  
8 was not seen for a staph-infection-caused wound until it developed into cellulitis and a necrotizing  
9 soft tissue infection, requiring intensive and invasive treatment. Another [inmate] had a staph  
10 infection-caused abscess that required the insertion of a surgical drain into the wound, which  
11 Defendants then failed to properly monitor and cleanse following the procedure."<sup>17</sup>

12  
13 Yet another example of Plaintiffs' medical care claims concern Defendants' alleged  
14 policies and practices for medical screening. Plaintiffs allege "Defendants fail to adequately train  
15 custody and medical staff in how to timely and appropriately identify medical problems during the  
16 screening and intake process. When [an inmate] is newly booked into the jail, medical staff may  
17

20 experienced significant delays before he was seen by medical staff. As one example, he submitted  
21 a sick call slip on October 2, 2012, complaining of not receiving certain medications for his  
22 stomach and was experiencing strong cramping pains; he was not fully evaluated by appropriate  
23 medical staff until October 26, 2012—24 days later." *Id.* at 44:12-24. As another example,  
24 Plaintiff Hernandez submitted sick call slips related to pain in his abdomen on November 18, 25,  
25 and December 2, 2012. He was not evaluated by an appropriate provider prior to being transferred  
26 to the hospital on or around December 11, 2013 for his ileostomy reversal surgery, a period of 23  
27 days." Plaintiffs similarly allege that "[w]hen Plaintiff Sarabi complained about intense pain in his

he was attacked by another inmate, one of the guards outside his room said, "You're a tough guy,  
suck it up, if you had broken your ankle you would be in more pain." *Id.* at 46:12-17.

1 not even play a role in screening the [inmate].”<sup>18</sup> Plaintiffs further allege that “[c]ustody staff (who  
 2 are not sufficiently trained to identify medical needs) complete a brief one-page health screening  
 3 form during a cursory interview with the [inmate] in a non-confidential space. Medical staff only  
 4 evaluate [inmates] at intake if the custody staff note a problem on the screening form. The  
 5 screening form used by custody fails to capture critical and basic information necessary to identify  
 6 [inmates] in need of medical attention.”<sup>19</sup>

7  
 8 Regarding Defendants’ alleged mental health policies and practices, in addition to intake  
 9 and tracking problems, Plaintiffs allege that “Defendants sometimes place [inmates] who arrive at  
 10 the jail and who are prescribed psychotropic medications on what Defendants call a detoxification  
 11 treatment. The detoxification treatment involves refusing, for up to 90 days, to provide [inmates]  
 12 with the psychotropic medications they were taking before they were booked into the Jail. . . .  
 13 [Inmates] placed on the detoxification treatment and removed from psychotropic medications  
 14 experience unnecessary pain and increases in psychiatric symptoms including paranoia,  
 15 hallucinations, and suicidality. . . . They are also at heightened risk of failing to respond to  
 16 medications once they are restarted.”<sup>20</sup> As one example, Plaintiff Murphy’s January 18, 2013  
 17 Intake Health Screening Form (completed by custody staff) and his Intake Triage Assessment form  
 18 (completed by medical staff of CFMG) indicated self-reported mental health problems. Further,  
 19 medical records in CFMG’s possession from a prior term Murphy had spent in the jail indicated he  
 20 suffered from mental illness and had received psychiatric medications. Only four days after intake  
 21 did Murphy have an appointment with a Licensed Psychiatric Technician who lacked authority to  
 22 prescribe treatment or medication. Murphy submitted several sick slips from that day on, stating:

1 “need psych meds – seeing and hearing things”; “need psych meds or psych hospital, Attn: head  
 2 psych please”; “I take varies physch medication . . . for hearing voices and seeing demons coming  
 3 out of the walls driving me crazy, can’t sleep or eat right at all. Ive been trying to see a physch  
 4 doctor, PLEASE help if possible”; “placing my life in serious danger and possible death after many  
 5 attempts to receive my medications during and after intake. I’m a disabled vet who served my  
 6 country with honorable discharge and should not be treated like trash over a officers attitude.” On  
 7 January 28, 2013 he informed staff that he was hearing demonic voices that were telling him to kill  
 8 himself. Consequently, Defendants placed Murphy in a rubber room, from which he was not  
 9 released until three days later. Murphy was not seen by mental health care staff with authority to  
 10 prescribe treatment until January 29, 2013.

11  
 12 As another example, Plaintiffs allege that Defendants house inmates with mental illness in  
 13 administrative segregation units in such a way that inmates suffer substantial risk of serious harm.<sup>21</sup>  
 14 Plaintiffs describe how “Jessie Crow and Daniel Lariviere committed suicide by hanging in  
 15 administrative segregation in 2010 and 2011 respectively. . . . [I]f Defendants had conducted safety  
 16 checks every half hour at intermittent and unpredictable times, they may have been able to prevent  
 17 Mr. Crow or Mr. Lariviere from committing suicide.”<sup>22</sup>

18  
 19 Plaintiffs allege inmates with mental illnesses are punished and discriminated against. For  
 20 example, after engaging in self-harming behavior, Plaintiff Mefford has been placed on suicide  
 21 watch and put in an “unsanitary” rubber room at least five separate times for varying lengths of  
 22 time since entering the jail. Mefford “was able to continue engaging in self-harming behavior  
 23 inside the rubber room, by banging his head repeatedly against the door until he was bleeding.”<sup>23</sup>

1 Custody staff responded by placing Mefford in a restraint chair. Mefford freed himself from the  
2 restraint chair at least once, and began again hurting himself. “Custody staff has routinely failed to  
3 conduct safety checks twice every thirty minutes as required by the Jail’s own policies. The Jail has  
4 also failed to provide him with adequate food and water during these periods of time. Plaintiff  
5 MEFFORD has informed the Jail medical and custody staff repeatedly that sensory deprivation and  
6 particularly a lack of light make his anxiety and other psychiatric conditions much worse. He has  
7 also stated a reluctance to express his true level of suicidality to staff because of fear of being  
8 placed in a rubber room. Despite this, custody staff continues to place him in rubber rooms.”<sup>24</sup>  
9  
10 These experiences show inadequate training, identification, tracking, treatment, suicide-watch,  
11 facilities, housing, prescription, monitoring, evaluation, records, as well as apparent discrimination  
12 and punishment of inmates with mental illnesses.<sup>25</sup>

13           Regarding Defendants’ alleged disabilities accommodation policies and practices, Plaintiffs  
14 claim Defendants’ failures to accurately identify new inmates’ disabilities and needed  
15 accommodations during the intake process result in the denial of accommodations mandated by the  
16 ADA, Rehabilitation Act, and California disability rights law, placing inmates at risk of  
17 discrimination, injury, and exploitation. For example, during booking into the jail in August 2012  
18 and again in December 2012, custody staff completed Monterey County Sheriff’s Office Intake  
19 Health Screening forms for Plaintiff Yancey. Despite Yancey’s complete hearing impairment, staff  
20 did not indicate on the forms that he had a hearing disability. Accordingly, staff throughout the jail  
21 were unable to identify Yancey as hearing impaired, and he received no accommodations for his  
22 disability.<sup>26</sup> Yancey was not provided with a sign language interpreter for his communications

1 with jail staff, including at medical appointments, at a disciplinary hearing, during the booking and  
2 classification process<sup>27</sup> or for church services.<sup>28</sup> Yancey submitted a grievance, requesting  
3 accommodations relating to his hearing impairment, but he received no response.<sup>29</sup>

4 Another inmate who was booked into the jail in January 2012 with a mobility impairment  
5 required a cane to help him safely ambulate and access his housing unit and required safe access to  
6 a bed. During the intake process, the jail failed to identify him as having a mobility impairment  
7 requiring those accommodations; he was not provided with a cane and he was placed in the only  
8 available bed in his housing unit on the upper bunk of a triple bunk. Without a cane, the inmate  
9 fell and injured himself on a number of occasions. He slept on the floor because it was too difficult  
10 to access his bunk.<sup>30</sup>

11 The sum total of all this is that Plaintiffs allege a variety of jail policies and practices  
12 applying to all inmates and staff dealing with safety, health care and disabilities, and that these  
13 policies and practices expose all members of the proposed class and subclass to a substantial risk of  
14 harm.  
15

16  
17 **B.**

18 Plaintiffs also support their motion for class certification with documents obtained by  
19 investigation and various requests pursuant to California's Public Records Act. For example, they  
20 submit Sheriff's Office's incident reports of the 2011 and 2012 incidents of violence between  
21 inmates alleged in the complaint.<sup>31</sup> Over 100 of these incidents led to at least one inmate requiring

1 medical treatment.<sup>32</sup> Widespread violent incidents were reported in 26 out of 29 housing units.<sup>33</sup>  
 2 Highlighting the impact of jail overcrowding on inmate safety, Plaintiffs also submit Defendants’  
 3 regular applications to the Superior Court for the County of Monterey for orders to release inmates  
 4 on an accelerated basis pursuant to California Penal Code § 4024.1.<sup>34</sup> To support these  
 5 applications, jail administrators repeatedly swore that unless the court authorized inmate releases,  
 6 the overcrowding in the jail would make it impossible for staff to “adequately supervise inmates  
 7 and to properly house them in accordance with the approved classification plan.”<sup>35</sup> In these  
 8 applications, CFMG Director Dr. Taylor Fithian also repeatedly “advised that the excessive  
 9 number of inmates housed in the jail compromises the health of the inmates and the staff working  
 10 at the facility.”<sup>36</sup> Jail administrators, including the Sheriff, also have addressed the impact of  
 11 overcrowding in other public forums.<sup>37</sup>

### 12 C.

13  
 14 Plaintiffs submit a total of eight reports from different experts on the policies and practices  
 15 in dispute. Four of these experts are independent of the parties, and were jointly retained by the  
 16 parties in 2013. At the parties’ request, the court ordered “a process of mutually agreeing to  
 17 experts who will review and analyze the conditions at the Monterey County Jail and issue  
 18 reports”<sup>38</sup> in four areas: medical care, mental health care, corrections and security and disability  
 19

1 accommodations and access.<sup>39</sup> The parties agreed that the resulting reports and recommendations  
2 would provide the framework for negotiating a remedial plan and consent decree. If settlement  
3 negotiations were unsuccessful, the parties agreed that the reports would be admissible evidence in  
4 the litigation.<sup>40</sup> The parties exchanged nominations and conferred to identify mutually acceptable  
5 neutral experts.<sup>41</sup> Two other reports were prepared in 2007 and 2011 by TRG Consulting, a private  
6 consulting firm, at the County's request.<sup>42</sup>

7  
8 The parties jointly retained Michael Hackett as a neutral expert to evaluate "whether  
9 Defendants adequately protect [inmates] from injury and violence in the Jail."<sup>43</sup> Hackett reported  
10 that staffing and housing is inadequate, the jail population is overcrowded and the old physical  
11 plant is not adequate for safety monitoring, therefore inciting violence. He concluded that  
12 Defendants operate the jail in a dangerous manner, placing all inmates at serious risk of harm.

13 The parties jointly retained Dr. Michael Puisis, D.O. as a neutral expert to evaluate  
14 "whether Defendants' system for providing medical care at the jail is adequate."<sup>44</sup> Puisis wrote  
15 that the jail's medical staffing is 40-70% less than it should be at all levels, leading to inadequate  
16 intake, evaluation, care, management and surveillance. Puisis also found the spaces of care  
17 delivery were unhygienic, inadequate and small, discouraging proper examinations. Almost every  
18 important policy governing medical care suffered from serious infirmities: intake, requests,  
19 emergency services, continuing medications, scheduling care, segregation and special needs.

1 Puisis concluded Defendants' system-wide policies and practices for providing medical care  
 2 harmed inmates or placed them at great risk of serious harm due to inadequate diagnosis, treatment  
 3 infection control, drug and alcohol withdrawal policies, and medical records.<sup>45</sup>

4 The parties jointly retained Dr. Richard Hayward, Ph.D. as a neutral expert to evaluate  
 5 "whether Defendants' system for providing mental health care in the jail is adequate."<sup>46</sup> Hayward  
 6 produced a draft report finding that Defendants' system-wide policies and practices for providing  
 7 mental health care place inmates at risk of serious harm.<sup>47</sup>

8 The parties jointly retained SZS Consulting as a neutral expert to evaluate Defendants'  
 9 compliance with the ADA and other disability rights laws.<sup>48</sup> SZS Consulting's detailed report  
 10 found that Defendants operate the jail in violation of the rights and needs of inmates with  
 11 disabilities.<sup>49</sup> SZS identified 119 architectural elements that did not comply with the relevant  
 12 guidelines.<sup>50</sup> Some of these barriers violated the requirements of federal and state law in multiple  
 13 ways.<sup>51</sup> The problems SZS identified include the following: the jail has far fewer housing areas  
 14

1 and cells available to inmates in wheelchairs than required by the relevant state and federal laws.<sup>52</sup>  
 2 None of the areas in which inmates are housed, either temporarily (e.g., holding cells, isolation  
 3 cells, and safety cells) or more permanently (housing units), are fully accessible to inmates in  
 4 wheelchairs.<sup>53</sup> Many areas of the jail in which Defendants offer programs, including housing,  
 5 health care and exercise, are partially or completely inaccessible to inmates with mobility  
 6 impairments, including those in wheelchairs. Not one medical exam room has adequate clearances  
 7 for inmates in wheelchairs.<sup>54</sup> Moreover, the exercise facilities for all inmates housed in Pods AJ,  
 8 K-Pod, the Women's Section, the Rotunda, and the Infirmary, were at least for some inmates  
 9 located on the roof of the jail, up a long flight of stairs; "[t]he result is that no accessible exercise  
 10 areas are provided in the facility for female inmates and male inmates have access to exercise areas  
 11 only if they are housed in dorms A, B, C, or D."<sup>55</sup>

12  
 13 TRG Consulting drafted the 2007 and 2011 reports at the County's request.<sup>56</sup> The 2007 and  
 14 2011 Jail Needs Assessments both concluded that, "[t]he current combination of insufficient beds,  
 15 an inadequate detention facility and understaffing has resulted in an almost untenable situation [at  
 16 the jail]."<sup>57</sup>

17  
 18 Plaintiffs also retained expert Dr. Pablo Stewart, M.D., a psychiatrist with decades of  
 19 experience evaluating correctional mental health care systems.<sup>58</sup> Stewart based his conclusions on

1 reviews of the reports of the joint experts, the relevant policies and procedures and other materials.  
 2 Stewart concluded that in nearly every respect, Defendants' policies and practices for delivering  
 3 mental health care to inmates in the jail places all inmates, especially those with serious mental  
 4 illness, at a substantial risk of serious harm.<sup>59</sup> Dr. Robert Cohen, M.D., a second medical expert  
 5 with experience as a director of medical services at Riker's Island,<sup>60</sup> found a variety of policies and  
 6 practices placed inmates at an unreasonable risk of harm, such as to do with tuberculosis,  
 7 medication continuity, withdrawal and staffing.  
 8

9 **D.**

10 Beyond the allegations in the second amended complaint, the investigation and public  
 11 records documents, and the expert reports, Plaintiffs also submitted declarations describing their  
 12 own experiences with jail policies and practices governing safety, medical care, mental health care  
 13 and disabilities. Plaintiffs did not submit these declarations in support of individual constitutional  
 14 and statutory claims, which they do not bring, but instead offer these declarations as evidence of  
 15 the defendants' unlawful policies and practices, and as examples of the serious harm to which all  
 16 inmates in jail custody are allegedly exposed. For example, Plaintiff Dilley, who suffers from  
 17 multiple sclerosis, describes how she cannot walk up the stairs to access the exercise yard without  
 18 experiencing excruciating pain.<sup>61</sup> Since she was booked into the jail in June 2013, she has only  
 19 been outside to go to court or medical appointments at outside facilities—she has not been outside  
 20 at all since mid-December 2013.<sup>62</sup> Plaintiff Miller has vision loss, and Defendants fail to ensure  
 21 that vision-impaired inmates are adequately informed of, among other things, administered  
 22

1 medications. This was the case when Defendants provided Miller with an improper insulin  
 2 injection and he lapsed into unconsciousness.<sup>63</sup> Each of the other named Plaintiffs submitted a  
 3 sworn declaration attesting to his or her experiences with jail safety, medical, mental health or  
 4 disabilities policies.<sup>64</sup>

### 5 III.

6 This court has jurisdiction under 28 U.S.C. §§ 1331 and 1367. The parties further  
 7 consented to the jurisdiction of the undersigned magistrate judge under 28 U.S.C. § 636(c) and  
 8 Fed. R. Civ. P. 72(a).<sup>65</sup>

9 Defendants again object to the Plaintiffs' standing.<sup>66</sup> The court declines to deviate from its  
 10 previous order denying Defendants' motions to dismiss for lack of standing.<sup>67</sup> As the court  
 11 previously explained, simply because an inmate does not use medical care, receives adequate care  
 12 once, or does not or get attacked does not mean they are not at an unreasonable risk when policies  
 13 and practices are deficient.<sup>68</sup> A transitional group of individuals suffer "injury in fact" if exposed  
 14 to unreasonable risk.<sup>69</sup> In any event, the claims at issue are current for at least one named  
 15 Plaintiff.<sup>70</sup>

## IV.

1  
2 Plaintiffs request that the court certify an inmate class of “all [inmates] who are now or will  
3 be in the future in the Jail” and an inmates with disabilities subclass of “all individuals who are  
4 now or will be in the future in the Jail and who have a disability, as defined by federal and  
5 California law.”<sup>71</sup> Plaintiffs also request that the court appoint Michael Bien and Gay Crosthwait  
6 Grunfeld of Rosen Bien Glavan & Grunfeld, LLP, James Egar of the Office of the Public  
7 Defender, County of Monterey, Alan Schlosser of the American Civil Liberties Union Foundation  
8 of Northern California, and Eric Balaban of the ACLU National Prison Project to represent the  
9 certified class and subclass pursuant to Rule 23(g).<sup>72</sup>

10  
11 “An order that certifies a class action must define the class and the class claims, issues, or  
12 defenses.”<sup>73</sup> Clearly delineating the contours of the class provides the parties with clarity and  
13 assists class members in understanding their rights and making informed opt-out decisions.<sup>74</sup> If

1 class members are impossible to identify without extensive and individualized fact-finding or  
2 “mini-trials,” then a class action is inappropriate.<sup>75</sup>

3 “The class action is ‘an exception to the usual rule that litigation is conducted by and on  
4 behalf of the individual named parties only.’”<sup>76</sup> To satisfy class certification requirements, such  
5 claims must be capable of satisfaction in “one stroke.”<sup>77</sup> To satisfy the four threshold requirements  
6 of Fed. R. Civ. P. 23(a), (1) the class must be “so numerous that joinder of all members is  
7 impracticable” (numerosity); (2) there must be “questions of law or fact common to the class”  
8 (commonality); (3) “the claims or defenses of the representative parties” must be “typical of the  
9 claims or defenses of the class” (typicality); and (4) the named plaintiffs must “fairly and  
10 adequately protect the interests of the class” (adequacy).<sup>78</sup> Plaintiffs seeking class certification  
11 must also satisfy the requirements of Rule 23(b), subdivisions 1, 2 or 3, which define three  
12 different types of classes.<sup>79</sup>

13  
14 In evaluating whether a party has met the requirements of Rule 23, “Rule 23 does not set  
15 forth a mere pleading standard.”<sup>80</sup> A party seeking class certification must “affirmatively  
16 demonstrate his compliance with the Rule—that is, he must be prepared to prove that there are *in*  
17

1 *fact* sufficiently numerous parties, common questions of law or fact, etc.”<sup>81</sup> Similarly a party must  
 2 affirmatively prove that he or she complies with one of the three subsections of Rule 23(b). This is  
 3 a “rigorous analysis”<sup>82</sup> that must “entail some overlap with the merits of the plaintiff’s underlying  
 4 claim.”<sup>83</sup> Rule 23(b) is “unquestionably satisfied when members of a putative class seek uniform  
 5 injunctive or declaratory relief from policies or practices that are generally applicable to the class  
 6 as a whole.”<sup>84</sup>

7  
 8 Rule 23(b)(1) allows a class action if “prosecuting separate actions by or against individual  
 9 class members would create a risk of (A) inconsistent or varying adjudications with respect to  
 10 individual class members that would establish incompatible standards of conduct for the party  
 11 opposing the class; or (B) adjudications with respect to individual class members that, as a practical  
 12 matter, would be dispositive of the interests of the other members not parties to the individual  
 13

1 adjudications or would substantially impair or impede their ability to protect their interests.”<sup>85</sup>

2 Prison condition cases have been certified under both 23(b)(1)(A)<sup>86</sup> and (B).<sup>87</sup>

3 Rule 23(b)(2) allows a class action if “the party opposing the class has acted or refused to  
4 act on grounds that apply generally to the class, so that final injunctive relief or corresponding  
5 declaratory relief is appropriate respecting the class as a whole.”<sup>88</sup> Rule 23(b)(2) is “almost  
6 automatically satisfied in actions primarily seeking injunctive relief.”<sup>89</sup> “The key to the (b)(2)  
7 class is ‘the indivisible nature of the injunctive or declaratory remedy warranted—the notion that  
8 the conduct is such that it can be enjoined or declared unlawful only as to all of the class members  
9 or as to none of them.’”<sup>90</sup> Rule 23(b)(2) requires a single injunction or declaratory judgment to  
10 provide relief to each member of the class. It does not authorize class certification when each  
11 individual class member would be entitled to a different injunction or declaratory judgment against  
12 the defendant.<sup>91</sup> Rule 23(b) is “unquestionably satisfied when members of a putative class seek

1 uniform injunctive or declaratory relief from policies or practices that are generally applicable to  
 2 the class as a whole. . . . [A]s the text of the rule makes clear, . . . [the rule] asks only whether ‘the  
 3 party opposing the class has acted or refused to act on grounds that apply generally to the class.’”<sup>92</sup>

4 In *Parsons v. Ryan*,<sup>93</sup> the Ninth Circuit held inmates challenging the constitutionality of  
 5 health care in the Arizona correctional system satisfied the requirements of Rule 23.<sup>94</sup> Such  
 6 “systemic, future oriented Eighth Amendment claim[s]”<sup>95</sup> claims were the “kind . . . firmly  
 7 established in our constitutional law,” in which inmates allege that “policies and practices of  
 8 [system-]wide application expose all inmates in . . . custody to a substantial *risk* of serious harm.”<sup>96</sup>  
 9 The plaintiffs in *Parsons* relied “on system-wide deficiencies in the provision of [safety and]  
 10 medical and mental health care that, taken as a whole, subject . . . [inmates] . . . to ‘substantial risk  
 11 of serious harm.’”<sup>97</sup> Disability discrimination claims under the Americans with Disabilities Act,  
 12 Rehabilitation Act, and California Government Code section 11135 are of the same type: requiring  
 13 injunctive relief from system-wide policies and practices, which institutionalize a failure to provide  
 14 necessary accommodations to inmates with all types of disabilities.<sup>98</sup>

15 Because Plaintiffs seek certification under Rule 23(b)(1) and (2), they need not show “that  
 16 the issues common to the class satisfy a Rule 23(b)(3)-like predominance test.”<sup>99</sup>

## A.

1  
2 As a preliminary matter, under the ascertainability doctrine, the class must be sufficiently  
3 definite so that it is feasible for the court to determine membership by reference to objective  
4 criteria.<sup>100</sup> Thus, a class is generally not ascertainable if membership in the class is based on  
5 subjective criteria, such as states of mind, or if the court would have to “make a determination  
6 about the merits of each claim in deciding whether a particular individual is a class member.”<sup>101</sup>  
7 The requirement helps to eliminate “serious administrative burdens that are incongruous with the  
8 efficiencies expected in a class action” by compelling easy identification of class members.<sup>102</sup> It  
9 also protects defendants by ensuring the identification of those bound by the final judgment.<sup>103</sup> But  
10 as a general matter, less precision is required of class definitions under Rule 23(b)(2) than  
11 under Rule 23(b)(3), where mandatory notice is required by due process.<sup>104</sup>

1 Defendants dispute the breadth of Plaintiffs' class and subclass definitions.<sup>105</sup> They  
 2 contend the class and subclass are not ascertainable because the definitions are vague, require mini-  
 3 trials and do not precisely identify future members.<sup>106</sup> But classes like the class and subclass here  
 4 have been routinely certified.<sup>107</sup> Class and subclass membership can "be ascertained by reference  
 5 to objective criteria," and the class definitions "avoid subjective standards (e.g. a plaintiff's state of  
 6 mind) or terms that depend on resolution of the merits (e.g., persons who were discriminated  
 7 against)."<sup>108</sup> The proposed class and subclass are sufficiently narrow: class members are those in  
 8 the jail, and subclass members are those with disabilities, as defined by federal and state law.<sup>109</sup>

10 **B.**

11 Rule 23(a)(1) requires that a class be "so numerous that joinder of all members is  
 12 impracticable." The Rule ensures judicial economy<sup>110</sup> and creates greater access to judicial relief,

1 particularly for those persons with claims that would be uneconomical to litigate individually,<sup>111</sup>  
 2 including for injunctive relief. A class or subclass with more than 40 members “raises a  
 3 presumption of impracticability based on numbers alone.”<sup>112</sup> This is especially true where, as here,  
 4 the class and subclass include future, unknowable class members.<sup>113</sup>

5 CFMG concedes and stipulates that Plaintiffs meet the numerosity element, and joinder of  
 6 all class members would be impracticable.<sup>114</sup> The County similarly does not argue against  
 7 numerosity.<sup>115</sup> Because the class and subclass are each over 40 members, and Defendants provide  
 8 no real opposition on this point, the court finds Plaintiffs meet the numerosity requirement.  
 9

### 10 C.

11 As to commonality, there must be “questions of law and fact common to the class,”<sup>116</sup> and  
 12 class members must “have suffered the same injury,” and not merely violations of “the same  
 13 provision of law.”<sup>117</sup> “[T]he class members’ claims ‘depend upon a common contention’ such that  
 14 ‘determination of its truth or falsity will resolve an issue that is central to the validity of each claim  
 15 in one stroke.’”<sup>118</sup> “Put another way, the key inquiry is not whether the plaintiffs have raised

1 common questions, ‘even in droves,’ but rather whether class treatment will ‘generate common  
2 *answers* apt to drive the resolution of the litigation.’”<sup>119</sup>

3 Dissimilarities between class members must be considered in determining whether a  
4 common question will generate a common answer because dissimilarities within the proposed class  
5 can “impede the generation of common answers.”<sup>120</sup> Thus commonality may be determined based  
6 on substantive law<sup>121</sup> and an understanding of the nature and merit of the underlying claims.<sup>122</sup>  
7 Plaintiffs need not show, however, that “every question in the case, or even a preponderance of  
8 questions, is capable of class-wide resolution. So long as there is ‘even a single common  
9 question,’ a would be class can satisfy the commonality requirement of Rule 23(a)(2).”<sup>123</sup> Thus,  
10 “[w]here the circumstances of each particular class member vary but retain a common core of  
11 factual or legal issues with the rest of the class, commonality exists.”<sup>124</sup>

12  
13 In civil rights cases, “commonality is satisfied where the lawsuit challenges a system-wide  
14 practice or policy that affects all of the putative class members.”<sup>125</sup> Where such a policy exists,  
15 “individual factual differences among the individual litigants or groups of litigants will not

1 preclude a finding of commonality.”<sup>126</sup> The Supreme Court’s *Wal-Mart* decision reaffirmed that  
 2 where a system-wide policy or practice is the cause of class members’ injuries, plaintiffs satisfy the  
 3 commonality requirement.<sup>127</sup>

4 Post-*Wal-Mart*, courts continue to find the commonality requirement satisfied in cases  
 5 challenging correctional facility conditions similar to those at issue here.<sup>128</sup> Recently, in  
 6 *Parsons*,<sup>129</sup> the defendants’ argument against commonality was that “a systemic constitutional  
 7 violation [of the sort alleged here] is a collection of individual constitutional violations, each of  
 8 which hinges on the particular facts and circumstances of each case.”<sup>130</sup> But the Ninth Circuit  
 9 affirmed class certification, holding that “[t]he putative class and subclass members . . . all set forth  
 10 numerous common contentions whose truth or falsity can be determined in one stroke: whether the  
 11 specified [system-]wide policies and practices to which they are all subjected . . . expose them to a  
 12

1 substantial risk of harm.”<sup>131</sup> Because of the nature of the plaintiffs’ system-wide challenge, “either  
 2 each of the policies and practices is unlawful as to every inmate or it is not.”<sup>132</sup> Any determination  
 3 of the merits would “not require [the court] to determine the effect of those policies and practices  
 4 upon any individual class member (or class members) or to undertake any other kind of  
 5 individualized determination.”<sup>133</sup>

6 “Commonality cannot be determined without a precise understanding of the nature of the  
 7 underlying claims.”<sup>134</sup> “To assess whether the putative class members share a common question,  
 8 the answer to which ‘will resolve an issue that is central to the validity of each one of the [class  
 9 members’s] claims,’ we must identify the elements of the class members’[] case-in-chief.”<sup>135</sup>

1 Here, a central question of injury is whether Defendants’ policies and practices reflect  
 2 deliberate indifference as to Plaintiffs’ medical care, mental health care, and safety needs.<sup>136</sup> The  
 3 court’s broad yes-or-no answer to that question is “apt to drive the resolution of the litigation”  
 4 because it determines whether Plaintiffs’ constitutional rights have been violated and whether an  
 5 injunction directing Defendants to remedy the constitutional violations is appropriate.<sup>137</sup> The  
 6 deliberate indifference standard focuses on the risk of future illness or injury to which defendants  
 7 expose inmates.<sup>138</sup> “This kind of claim is firmly established in our constitutional law.”<sup>139</sup>

1 Defendants argue that what is reasonable treatment to one inmate may not be appropriate or  
 2 reasonable treatment to another<sup>140</sup>—and whether Defendants have acted with deliberate  
 3 indifference—will require distinct legal questions, burdens of proof and “mini-trials” for each  
 4 Plaintiff.<sup>141</sup> System-wide allegations require proof of either an official policy or admissible and  
 5 convincing proof rather than just allegations that a constitutional violation persists system-  
 6 wide<sup>142</sup>—something Plaintiffs cannot show, according to Defendants.<sup>143</sup>

7  
 8 But Plaintiffs have produced adequate evidence of specific system-wide policies and  
 9 practices exposing inmates to a substantial risk of serious harm, violating their constitutional or  
 10 statutory rights; and they have clearly defined the class claims.<sup>144</sup> “That the Eighth Amendment  
 11 protects against future harm to inmates is not a novel proposition.”<sup>145</sup> Noting that it “would be odd  
 12 to deny an injunction to inmates who plainly proved an unsafe, life-threatening condition in their  
 13 prison on the ground that nothing yet had happened to them,” *Helling* rejected a proposition like  
 14 the Defendants’ here that “only deliberate indifference to current serious health problems of  
 15

1 inmates is actionable under the Eighth Amendment.”<sup>146</sup> In *Farmer v. Brennan*, the Court  
 2 elaborated on *Helling*’s recognition that a “remedy for unsafe conditions need not await a tragic  
 3 event”<sup>147</sup> by holding that “[a] prison official’s ‘deliberate indifference’ to a substantial risk of  
 4 serious harm to an inmate violates the Eighth Amendment.”<sup>148</sup> Prison officials are definitively  
 5 constitutionally prohibited from being deliberately indifferent to policies and practices that expose  
 6 inmates to a substantial risk of serious harm.<sup>149</sup>

7  
 8 In *Brown v. Plata*, the Supreme Court distinguished the kind of systemic, future-oriented  
 9 constitutional and statutory claims at issue here from claims in which a past instance of  
 10 mistreatment is alleged to have violated the Constitution:

11 Because plaintiffs do not base their case on deficiencies in care provided on any one  
 12 occasion, this Court has no occasion to consider whether these instances of delay—or any  
 13 other particular deficiency in medical care complained of by the plaintiffs—would violate  
 14 the Constitution under *Estelle v. Gamble*, 429 U.S. 97, 104–105 . . . (1976), if considered in  
 15 isolation. Plaintiffs rely on system-wide deficiencies in the provision of medical and mental  
 16 health care that, taken as a whole, subject sick and mentally ill [inmates] in California to  
 “substantial risk of serious harm” and cause the delivery of care in the prisons to fall below  
 the evolving standards of decency that mark the progress of a maturing society.<sup>150</sup>

1 Thus, “[i]ndividual claims for injunctive relief related to medical treatment are discrete  
 2 from the claims for systemic reform addressed in *Plata*”<sup>151</sup> and here. The constitutional and  
 3 statutory claims in this case are of the same basic kind as the claims in *Helling*, *Farmer*, *Plata*,  
 4 *Graves*, *Wallis*, and *Parsons*. In those cases, courts have asked only whether the plaintiffs were  
 5 exposed to a substantial risk of harm to which prison officials were deliberately indifferent—and  
 6 have recognized that many inmates can simultaneously be endangered by a single policy.<sup>152</sup>

7  
 8 Here, all members of the putative class and subclass have in common their alleged exposure  
 9 to a substantial risk of serious future harm to which Defendants are allegedly deliberately  
 10 indifferent, as a result of policies and practices that govern the overall conditions of health care  
 11 services and confinement.<sup>153</sup> While results of exposure may vary, ranging from no harm to death,  
 12 each inmate suffers the same constitutional or statutory injury when exposed to a policy or practice  
 13 that creates a substantial risk of serious harm.<sup>154</sup> For example, inadequate health care in a prison  
 14 system endangers every inmate: “[e]ven [inmates] with no present physical or mental illness may  
 15 become afflicted, and all [inmates] in California are at risk so long as the State continues to provide  
 16 inadequate care. . . . [Inmates] who are not sick or mentally ill . . . [are] in no sense [ ] remote  
 17 bystanders in California's medical care system. They are that system's next potential victims.”<sup>155</sup>

1 The court need only determine if it can answer the question “whether [Defendants’] staffing  
 2 policies pose a risk of serious harm to . . . the entire class ‘in one stroke.’”<sup>156</sup> The identified 37  
 3 policies and practices to which all members are exposed hold together the putative class and  
 4 subclass.<sup>157</sup>

5 Defendants’ proffered changes in intake health screening and the future hiring of more  
 6 medical staff, even if successful, cannot defeat commonality.<sup>158</sup> “Either [Defendants] employ[]  
 7 enough nurses and doctors [and custody staff] to provide adequate care to all . . . inmates or [they]  
 8 do[] not; there is no need for an inmate-by-inmate inquiry to determine whether all inmates in [the  
 9 Jail] are exposed to a substantial risk of serious harm by [Defendants’] staffing policies.”<sup>159</sup>  
 10 CFMG and the County admit to mistakes in care and treatment, and their knowledge of the risks to  
 11 which their acknowledged system-wide policies and practices expose Plaintiffs can be evaluated on  
 12 a class-wide basis.<sup>160</sup> The County also admits to system-wide, insufficient accommodations for  
 13 persons with disabilities,<sup>161</sup> and whether Defendants had knowledge of any insufficiencies can also  
 14 be evaluated in “one-stroke” for the entire sub-class. No individualized inquiry into the  
 15 experiences of any particular inmate or Plaintiff is necessary. The claims of the inmates with  
 16 disabilities sub-class also satisfy the commonality requirement: either the Plaintiffs are housed in a  
 17

1 facility that comports with the ADA or they are not.<sup>162</sup> As exemplified by *Plata*, claims of this  
 2 kind, involving detailed factual and legal allegations of specified systemic deficiencies in prison  
 3 conditions giving rise to a substantial risk of serious harm, have long been brought in the form of  
 4 class actions lawsuits.<sup>163</sup> “In fact, without such a means of challenging unconstitutional prison  
 5 conditions, it is unlikely that a state's maintenance of prison conditions that violate the Eighth  
 6 Amendment could ever be corrected by legal action.”<sup>164</sup>

1 Here, as in *Parsons*, Plaintiffs have met or exceeded *Wal-Mart*'s requirement of proof that  
 2 there are “*in fact . . . common questions of law or fact.*”<sup>165</sup> The materials that they submitted  
 3 include six thorough and neutral or County-appointed expert reports, two Plaintiff-retained expert  
 4 declarations, the detailed allegations in the 135-page complaint, hundreds of internal documents,  
 5 and declarations by the named Plaintiffs—constituting more than sufficient evidence at this stage  
 6 in the litigation of the existence of policies and practices that allegedly expose all members of the  
 7 putative class and subclass to a substantial risk of serious harm. These policies and practices are  
 8 defined with sufficient precision and specificity; they involve particular and readily identifiable  
 9 conduct on the part of the defendants, such as failing to hire enough medical staff, failing to fill  
 10 prescriptions, denying inmates access to medical specialists, depriving suicidal and mentally ill  
 11 inmates access to basic mental health care, and failure to accommodate disabilities that affect  
 12 communication and mobility.<sup>166</sup> The evidence submitted by the plaintiffs adequately demonstrates  
 13 the existence of the challenged statewide policies and practices.  
 14

15  
 16 “A clear line of precedent, stretching back long before *Wal-Mart* and unquestionably  
 17 continuing past it, firmly establishes that when inmates provide sufficient evidence of systemic and  
 18 centralized policies or practices in a prison system that allegedly expose all inmates in that system  
 19 to a substantial risk of serious future harm, Rule 23(a)(2) is satisfied.”<sup>167</sup> Here, Plaintiffs’

1 constitutional and statutory claims satisfy all of those criteria. The factual and legal questions that  
 2 they present can be answered “yes” or “no” in one stroke as to the entire class, dissimilarities  
 3 among class members do not impede the generation of common answers to those questions, and the  
 4 capacity of class-wide proceedings to drive the resolution of this litigation is not in doubt.<sup>168</sup> The  
 5 claims, defenses, relevant facts, and substantive law are all common across the class and  
 6 subclass.<sup>169</sup>

7  
 8 **D.**

9 The question of typicality<sup>170</sup> “refers to the nature of the claim or defense of the class  
 10 representative, and not to the specific facts from which it arose or the relief sought.”<sup>171</sup> “[T]he  
 11 typicality inquiry involves comparing the injury asserted in the claims raised by the named  
 12 plaintiffs with those of the rest of the class.”<sup>172</sup> “Under the rule’s permissive standards,  
 13 representative claims are ‘typical’ if they are reasonably co-extensive with those of absent class  
 14 members; they need not be substantially identical.”<sup>173</sup> The test of typicality is “whether other  
 15 members have the same or similar injury, whether the action is based on conduct which is not  
 16 unique to the named plaintiffs and whether other class members have been injured by the same  
 17

1 course of conduct.”<sup>174</sup> “Typicality refers to the nature of the claim or defense of the class  
2 representative, and not to the specific facts from which it arose or the relief sought.”<sup>175</sup>

3 While typicality and commonality occasionally merge,<sup>176</sup> typicality derives its independent  
4 legal significance from its ability to “screen out class actions in which the legal or factual position  
5 of the representatives is markedly different from that of other members of the class even though  
6 common issues of law or fact are present.”<sup>177</sup> But it is not necessary “that the named plaintiffs’  
7 injuries be identical to those of other class members, only that the unnamed class members have  
8 injuries similar to those of the named plaintiffs and that the injuries result from the same, injurious  
9 course of conduct.”<sup>178</sup>

10  
11 To the County, the typical grievances and complaints named Plaintiffs make in this case are  
12 adequacy or timely care, which Defendants believe are individual, unique issues, requiring  
13 individual, unique responses and assessments of specific inquiries on an individual level.<sup>179</sup> The  
14 determination of deliberate indifference, the County asserts, would require individual analysis,  
15 undermining any judicial economy found in certifying a class.<sup>180</sup> Using the same defenses as for  
16 commonality, CFMG attempts to discount any problems any named Plaintiff has had with any  
17 aspect of CFMG’s medical and mental care, but the medical records show otherwise.<sup>181</sup>

Here, the transitory putative class and subclass members are all inmates in the jail. Each named Plaintiff declares exposure, like all other members of the putative class and subclass, to a substantial risk of serious harm due to the challenged policies and practices. The named Plaintiffs allege “the same or [a] similar injury” as the rest of the putative class; they allege that this injury is a result of a course of conduct that is not unique to any of them; and they allege that this injury follows from the “same, injurious course of conduct” at the center of the class claims.<sup>182</sup> Relief for one individual would provide relief to everyone.<sup>183</sup> “[G]iven that *every* inmate in [the Jail] is highly likely to require medical, mental health, and dental care, each of the named plaintiffs is similarly positioned to all other [Jail] inmates with respect to a substantial risk of serious harm resulting from exposure to defendants’ policies and practices.”<sup>184</sup> This applies as well for the subclass. “It does not matter that the named plaintiffs may have in the past suffered varying injuries or that they may currently have different health care needs; Rule 23(a)(3) requires only that their claims be ‘typical’ of the class, not that they be identically positioned to each other or to every class member.”<sup>185</sup>

**E.**

As to adequacy of representation,<sup>186</sup> class representatives are adequate if they do not have “any conflicts of interest with other class members” and if they will “prosecute the action

1 vigorously on behalf of the class.”<sup>187</sup> Class representatives have less risk of conflict with unnamed  
2 class members when they seek only declaratory and injunctive relief. With regard to claims, the  
3 honesty and credibility of a class representative is a relevant consideration into adequacy, because  
4 an untrustworthy plaintiff could reduce the likelihood of prevailing on the class action<sup>188</sup> and may  
5 be considered to have interests antagonistic to the class.<sup>189</sup> But a plaintiff is inadequate only “when  
6 attacks on the [plaintiff’s] credibility . . . are so sharp as to jeopardize the interests of absent class  
7 members” and “where the representative’s credibility is questioned on issues directly relevant to  
8 the litigation.”<sup>190</sup>

9  
10 The County argues that the named Plaintiffs are inadequate because, among other things,  
11 they request conflicting relief. For example, some Plaintiffs wish to see mentally ill inmates  
12 segregated from the rest of the inmates, and others admonish Defendants for failure to “ensure that  
13 inmates or detainees with disabilities are housed in the most integrated setting appropriate to the  
14 needs of the individuals.”<sup>191</sup> Citing certain deposition testimony and counsel’s role in preparing  
15 defendants, CFMG contends the named Plaintiffs are not adequate representatives because they are  
16 not credible and because they can establish neither the requisite case or controversy nor personal  
17 injury from being subjected to the alleged risks.<sup>192</sup> As to this latter point, CFMG disputes that any  
18 named Plaintiffs were exposed to the inadequate conditions they challenge relating to in screening,

1 staffing, facilities, requests for care, care, treatment quality management, training, suicide  
 2 prevention and use of safety cells.<sup>193</sup> CFMG also questions whether certain Plaintiffs suffering  
 3 from mental illness can adequately represent a class.<sup>194</sup>

4 Any minor disagreements between various class representatives' individual beliefs  
 5 regarding appropriate remedies do not render the class representatives inadequate. Rather than  
 6 personal relief, Plaintiffs ask for relief from Defendants' problematic system-wide policies and  
 7 practices. For example, while opinions may differ about housing inmates with mental illness in  
 8 general population or in special housing units, all plaintiffs agree inmates with mental illnesses  
 9 should not be housed in administrative segregation, and this is part of the relief they request.<sup>195</sup>  
 10 And "[i]nconsistent deposition testimony in and of itself will not serve as a ground for denial of  
 11 class certification."<sup>196</sup> While lack of credibility is an issue for Plaintiffs to consider in constructing  
 12 their case, the court does not consider the named Plaintiffs inadequate. Nor are alleged cognitive  
 13 impairments a valid reason to deem Plaintiffs inadequate.<sup>197</sup>

#### 14 F.

15  
 16  
 17 Counsel may be appointed under Fed. R. Civ. P. 23(g)(1) and (4) if they are adequate; that  
 18 is, if counsel does not have "any conflicts of interest with other class members" and if they will

1 “prosecute the action vigorously on behalf of the class.”<sup>198</sup> Here, appointment is sought by the  
 2 following counsel: Rosen Bien Galvan & Grunfeld LLP, Monterey County Public Defender James  
 3 Egar and the American Civil Liberties Union.

4 Under Fed. R. Civ. P. 23(g)(1) and (4), class counsel with experience with class action  
 5 lawsuits, class action lawsuits regarding conditions in correctional facilities, criminal justice issues  
 6 and commitment of resources are likely to adequately represent the class.<sup>199</sup>

7 The County posits that the Rosen Bien firm may be financially interested in keeping  
 8 inmates in jail, while the Office of the Public Defender’s incentives may aim to keep inmates out of  
 9 jail.<sup>200</sup> The County further argues the Office of the Public Defender has declared conflict in  
 10 representing six of the named Plaintiffs.<sup>201</sup> The County also claims that because Egar filed a  
 11 declaration in support of Plaintiffs’ motion for class certification in which he testified to his  
 12 personal knowledge of the conditions at the jail, he is a witness in this lawsuit, disqualifying him  
 13 from representation in this lawsuit.<sup>202</sup> CFMG focuses on a letter Egar once wrote lauding Fithian’s  
 14 work.<sup>203</sup>

1 Defendants' arguments as to plaintiffs' counsel's conflicting incentives are unpersuasive,  
 2 especially where the class is transitory<sup>204</sup> and where Rosen Bien advocates for reducing jail and  
 3 prison overcrowding.<sup>205</sup> Pursuant to Cal. Gov. Code § 27706(g), conflicts in criminal cases do not  
 4 carry over into civil cases,<sup>206</sup> and Egar's representation does not implicate California ethics  
 5 rules.<sup>207</sup> An attorney may be both counsel and witness in a single action, although Plaintiffs have  
 6 stated they do not intend to call Egar to testify.<sup>208</sup> The letter Egar once sent to Fithian also does not  
 7 undermine his ability to represent the plaintiffs adequately. Rosen Bien Galvan & Grunfeld LLP,  
 8 Egar and the ACLU all have the necessary experience and resources to litigate cases such as this  
 9 one.  
 10

11 **G.**

12 Rule 23(b)(2) requires that "the party opposing the class has acted or refused to act on  
 13 grounds that apply generally to the class, so that final injunctive relief or corresponding declaratory  
 14 relief is appropriate respecting the class as a whole." *Wal-Mart* summarized Rule 23(b)(2)'s  
 15 requirements as follows:  
 16

17 the key to the (b)(2) class is "the indivisible nature of the injunctive or declaratory remedy  
 18 warranted—the notion that the conduct is such that it can be enjoined or declared unlawful  
 only as to all of the class members or as to none of them." In other words, Rule 23(b)(2)

1 applies only when a single injunction or declaratory judgment would provide relief to each  
 2 member of the class. It does not authorize class certification when each individual class  
 3 member would be entitled to a *different* injunction or declaratory judgment against the  
 4 defendant.<sup>209</sup>

5 These requirements unquestionably are satisfied when putative class members seek uniform  
 6 injunctive or declaratory relief from policies or practices generally applicable to the class as a  
 7 whole.<sup>210</sup> Such an inquiry “does not require an examination of the viability or bases of the class  
 8 members’ claims for relief, does not require that the issues common to the class satisfy a Rule  
 9 23(b)(3)-like predominance test, and does not require a finding that all members of the class have  
 10 suffered identical injuries.”<sup>211</sup> Rather, as the rule’s text makes clear, this inquiry asks only whether  
 11 “the party opposing the class has acted or refused to act on grounds that apply generally to the  
 12 class.”<sup>212</sup>

13 The primary role of this provision is the certification of civil rights class actions.<sup>213</sup>

14 Following Rule 23(b)(2)’s text and purpose, courts have repeatedly invoked it to certify classes of

1 inmates seeking declaratory and injunctive relief for alleged widespread constitutional and  
 2 statutory violations in prison systems.<sup>214</sup>

3 As in *Parsons*, here Plaintiffs “seek uniform injunctive or declaratory relief from policies or  
 4 practices that are generally applicable to the class as a whole.”<sup>215</sup> In their prayer for relief,  
 5 Plaintiffs request that Defendants be ordered “to protect [inmates] from substantial risk of harm  
 6 from other [inmates], to provide minimally adequate medical [and mental] care to [inmates], and to  
 7 cease discriminating against and failing to provide accommodations to [inmates] with disabilities; .  
 8 . . from continuing the unlawful acts, conditions, and practices described in this Complaint; . . . to  
 9 develop and implement, as soon as practical, a plan to eliminate the substantial risk of harm,  
 10 discrimination, and statutory violations that Plaintiffs and members of the class and subclass they  
 11 represent suffer due to the unlawful acts, omissions, conditions and practices described in this  
 12 Complaint [detailing needs for population, staffing, physical plant, protection from harm, training,  
 13 classification and housing, medical care, access to care, medical staffing, emergency care, chronic  
 14 care, medical records, specialist and outside treatment, mental health care, quality assurance, and  
 15 accommodation for inmates with disabilities]; . . . the costs of this suit and reasonable attorneys’  
 16 fees and litigation expenses; . . . retaining jurisdiction . . . until Defendants have fully complied  
 17 with the orders of this Court, and there is reasonable assurance that Defendants will continue to  
 18 comply in the future absent continuing jurisdiction; and [a]n award to Plaintiffs of such other and

1 further relief as the Court deems just and proper.”<sup>216</sup> Plaintiffs’ expert reports also include  
 2 descriptions of the kinds of court-ordered changes in the jail’s policy and practices that could  
 3 alleviate the alleged systemic constitutional and statutory violations, as well as affirmations by all  
 4 experts that court-ordered injunctive relief could effectively alleviate the deficiencies in the jail’s  
 5 policies and practices identified in their reports.

6 The County argues Plaintiffs’ requests are too vague regarding constitutional adequacy and  
 7 deficiency.<sup>217</sup> But the civil rights claims of the inmate class and the inmates with disabilities  
 8 subclass “are precisely the sorts of claims that Rule 23(b)(2) was designed to facilitate.”<sup>218</sup>  
 9 Defendants “ha[ve] acted or refused to act on grounds that apply generally to the class, so that final  
 10 injunctive relief or corresponding declaratory relief is appropriate respecting the class as a  
 11 whole.”<sup>219</sup> Plaintiffs satisfy Rule 23(b)(2) because “class members seek uniform relief from a  
 12 practice applicable to all of them.”<sup>220</sup> “Contrary to the [D]efendants’ assertion that each inmate’s  
 13 alleged injury is amenable only to individualized remedy, every inmate in the proposed class is  
 14 allegedly suffering the same (or at least a similar) injury and that injury can be alleviated for every  
 15 class member by uniform changes in [jail] policy and practice.”<sup>221</sup> Plaintiffs request no damages or  
 16 relief for any specific Plaintiff.<sup>222</sup> Instead, Plaintiffs seek injunctive and declaratory relief from a  
 17

1 specific set of Defendants’ policies and practices,<sup>223</sup> and while each may not affect every member  
 2 of the proposed class and subclass in exactly the same way, they constitute shared grounds for all  
 3 inmates in the proposed classes.<sup>224</sup> “For example, every inmate in [jail] custody is allegedly placed  
 4 at risk of harm by [the jail’s] policy and practice of failing to employ enough doctors—an injury  
 5 that can be remedied on a class-wide basis by an injunction that requires [the jail] to hire more  
 6 doctors, with the exact number of necessary additional hires to be determined by the district court  
 7 if, after a trial, it ultimately concludes that the defendants engaged in unlawful conduct.”<sup>225</sup>  
 8 Because Defendants allegedly established systemic policies and practices that place every inmate  
 9 in the jail in peril, and by allegedly doing so with deliberate indifference to the resulting risk of  
 10 serious harm to them, Defendants have acted on grounds that apply generally to the proposed class  
 11 and subclass, such that Plaintiffs’ prayer for relief would provide an appropriate remedy for  
 12 both.<sup>226</sup> Accordingly, Plaintiffs satisfy Rule 23(b)(2).

#### V.

15 The court GRANTS Plaintiffs’ motion for class certification under Rule 23(b)(2), and  
 16 appoints named Plaintiffs as class representatives. The court also designates as class counsel under  
 17 Rule 23(g) Michael Bien and Gay Crosthwait Grunfeld of Rosen Bien Galvan & Grunfeld LLP,
